is completed and rolled out at a community forum.



The **500-Unit Plan is developed**, establishing the framework for the need for additional supportive housing units in the community.



2011

SJMHS commits \$1 million, establishing SYG Fund,

a dedicated revenue stream for supportive housing services in Washtenaw County. The dedicated source is a recommendation of the Blueprint to End Homelessness, and the County Task Force.



County task force recommends three strategies to provide sustainable revenue

to support supportive services at 500 new units of permanent supportive housing (PSH) including:

- **1.** A \$60 million endowment with annual distribution of \$2.5 million
- 2. Millage strategy put on hold due to 2008 financial crisis
- 3. Public education continues through the WHA



The county task force completes its work and presents a report with recommendations,

which is approved by the BoC.
The report recommends
to begin Phase II of the process by
establishing Public Education,
Millage Strategy, and Private
Endowment work groups.



As part of the Blueprint to End Homelessness implementation, the

BoC creates a task force

to "explore locally viable long-term revenue sources for the creation and sustainability of supportive housing units and related services."



AAACF matches the SJMHS commitment with a \$1 million pledge to the SYG Fund.



An Endowment Feasibility Study by Hammond & Associates is completed.

The report identifies the need for staff support to grow the endowment.



The BoC sunsets the County Task Force and work groups, and creates the SYG Fund (PSH) Cabinet

to continue to grow an endowment for PSH services. **The first distribution of \$26,000** is provided

through AAACF to Avalon Housing.



A SYG Fund Development Coordinator staff position is established with financial support from the WHA,

AAACF, and an anonymous donor.



Annual distribution reaches \$149,988, to be distributed to non-profit agencies providing PSH services.



SYG Fund receives a \$500K
Challenge Match from local foundation,
a new \$1M commitment from Trinity Health,
and the Fund reaches a valuation
over \$8 million.



SYG Fund valuation reaches approximately \$4 million.

Annual distribution reaches \$79,000.

Over 200 donors have contributed to the SYG Fund, including individuals, corporations, and foundations.



SYG Fund Development Coordinator position becomes an independent contractor through WHA and is financially supported by the WHA and SIMHS.
